1. Call to Order

2. Violence Interrupter Discussion

At the last Mayor/CAO Roundtable meeting, staff was directed to organize the next Roundtable meeting around a discussion with local violence interrupter programs. The CAOs and HRPDC staff held a discussion with representatives of these programs to learn more about these efforts. Following this discussion, representatives were appointed to attend the Mayor/CAO Roundtable to share their insights and recommendations. This is the same approach that has been used for previous conversations with the region's Commonwealth Attorneys, Police Chiefs, and Mental Health Professionals.

Representatives from Ketchmore Kids, League of Advocates, and Let Our Voice Empower will be in attendance to brief the Mayor/CAO Roundtable on their programs and efforts. Each program will be provided ten minutes to brief the Mayors and CAOs to allow an opportunity for questions and discussion.

Following these briefings, the Mayors and CAOs should discuss this information and identify any actions/strategies that can be advanced.

3. Discussion of Next Steps (Attachment 3)

During previous Mayor/CAO Roundtable Work Sessions, the attached Regional Violence Prevention Framework was reviewed. This framework is intended to illustrate the complexity of issues related to violence and crime and to stress the need for a holistic strategy to address issues related to the following topics:

- Concentrated Poverty
- Access to Guns
- Desensitized Communities and Individuals
- Judicial System
- Mental Health/Unaddressed Trauma
- Family Dysfunction
- Poor Conflict Resolution

The Mayors and CAOs should provide staff direction on the next topic area for discussion by the Roundtable.

4. Items of Regional Interest

The Roundtable members will be provided an opportunity to share information regarding crime and violence prevention efforts in their locality that may be of regional interest.
