Dear Mr. Crum:

The Virginia Department of Transportation (VDOT) requests a TIP Amendment from the Hampton Roads Transportation Planning Organization (HRTPO) to amend the FY 2024-2027 Transportation Improvement Program (TIP) to add UPC 107414 to the TIP as an individual project as part of the FY 2024-2027 rollover process as the project contains Congestion Mitigation and Air Quality (CMAQ) Improvement Program funds.

The specific details of the request are as follows:

- **UPC 107414 – Roaring Springs Road (Route 616) Bicycle/Pedestrian Improvements**
 - Add project to TIP as part of the rollover process.
 - Description: This project will construct pedestrian facilities (6-foot sidewalk) on Rte. 616 Roaring Springs Road. The project would add approximately 2,000 feet of sidewalk and approximately 250 feet of curb & gutter along the east side of Rte. 616 Roaring Springs Road starting at 17B and extending to Wyncote.
 - Jurisdiction/Agency: Gloucester
 - Length: 0.38 miles
 - Termini: From 17B to Wyncote
 - System: Secondary
 - Scope: Facilities for Pedestrians
 - Oversight: Federal Oversight
 - Administered by: VDOT
 - Regionally Significant: No
 - CMAQ: Yes
 - RSTP: No
