The Virginia Department of Transportation (VDOT) requests a TIP Amendment from the Hampton Roads Transportation Planning Organization (HRTPO) to revise the estimate, schedule, obligations and allocations for UPC 115423, George Washington Highway Widening, in the FY 2024-27 TIP.
