The Virginia Department of Transportation (VDOT) requests a TIP Amendment from the Hampton Roads Transportation Planning Organization (HRTPO) revise the cost estimate, schedule, and obligations for UPC 120863, Hampton Roads Express Lanes, Segment 1B in the FY 2024-27 TIP. This project will convert the inside shoulder along I-64 to a part-time HOT managed lane from 0.661 miles east of Tidewater Drive to 1.04 miles east of I-264. Fiscal constraint of the subject project is demonstrated. The deficient of \$87,827,648 will be funded by HRTAC outside of the current TIP years. To that end, we request UPC 120863 be revised in the FY 2024-27 TIP including the following information:
