**UPC 125243 – Suffolk Seaboard Coastline Trail – Segment 3C**

Attached is a request from the Virginia Department of Transportation (VDOT) to amend the FY 2024-2027 HRTPO Transportation Improvement Program (TIP) to add UPC 125243 to the TIP.

The specifics of the request are described below:

- **UPC 125243 – Suffolk Seaboard Coastline Trail – Segment 3C**
  - Add project to the TIP.
  - Description: Construct a 2.7-mile trail segment, from the northern terminus of Segment 3B at Pine Tree Way to Nansemond River High School, completing the gap between Segments 3A and 3B of the trail.
  - System: Enhancement
  - Scope: Facilities for Pedestrians and Bicycles
  - Oversight: Non-Federal Oversight
  - Administered By: Locality
  - Regionally Significant: No
  - Cost Estimate as follows:
    - Preliminary Engineering (PE): \$737,100
    - Right of Way (RW): \$3,572,100
    - Construction (CN): \$4,139,381
    - Total Cost Estimate: \$8,448,581
  - Schedule as follows:
    - PE Start: 1/22/2025; End: 3/17/2027
    - RW Start: 3/17/2027; End: 12/8/2027
    - CN Start: 12/8/2027; End: 11/23/2028
  - Allocations as follows:
    - Add FY 2025 Transportation Alternatives Program (TAP) allocation of \$2,200,000, plus \$550,000 TAP match
    - Add FY 2026 TAP allocation of \$300,000, plus \$75,000 TAP match
    - Add FY 2025 Rebuilding American Infrastructure with Sustainability and Equity (RAISE) allocation of \$5,319,360
    - Add FY 2025 Local (LOC) allocation of \$4,221
  - Obligations as follows:
    - Add FY 2025 PE Phase Transportation Alternatives Program/Flex (TAP/F) obligation of \$589,680, plus \$147,420 TAP/F match
    - Add FY 2027 RW Phase TAP/F obligation of \$1,910,320, plus \$477,580 TAP match
    - Add FY 2027 RW Phase Other obligation of \$1,184,200

UPC 125243 is being added to the Hampton Roads FY 2024-2027 TIP, is consistent with the HRTPO 2045 Long-Range Transportation Plan (LRTP), and is fiscally constrained as required by Federal Code 40 CFR 93.108. The project is exempt from conformity under the *Air Quality* provision contained in conformity rule 40 CFR 93.126 (Table 2 Exempt projects), as it is a bicycle and pedestrian project. A new conformity determination is not required per the [Procedures for Inter-Agency Consultation for Conformity for Hampton Roads.](#)

This request is being made available for public review and comment from November 6, 2024 through November 20, 2024.

The Virginia Department of Transportation (VDOT) requests a TIP Amendment from the Hampton Roads Transportation Planning Organization (HRTPO) to add UPC 125243, Suffolk Seaboard Coastline Trail-3C, to the FY 2024-27 TIP.
