UPC 125602 – I-64/I-264 Interchange Phase IIIA**

Attached is a request from the Virginia Department of Transportation (VDOT) to amend the FY 2024-2027 HRTPO Transportation Improvement Program (TIP) to add UPC 125602 to the TIP.

The specifics of the request are described below:

- **UPC 125602 – I-64/I-264 Interchange Phase IIIA**
 - Add project to the TIP.
 - Description: Widen I-64 EB from four to five lanes, including the reconstruction of the interchange flyover ramp from I-64 EB to I-264 EB, and the widening of three existing bridges. Managed lane infrastructure will be installed in the eastbound median.
 - System: Interstate
 - Scope: Reconstruction w/Added Capacity
 - Oversight: Non-Federal Oversight
 - Administered By: VDOT
 - Regionally Significant: Yes
 - Cost Estimate as follows:
 - Preliminary Engineering (PE): \$1,880,000
 - Right of Way (RW): \$8,037,000
 - Construction (CN): \$507,099,000
 - Total Cost Estimate: \$517,016,000
 - Schedule as follows:
 - PE Start: 10/18/2024; End: 1/14/2026
 - RW Start: 1/14/2026; End: 1/23/2026
 - CN Start: 1/23/2026; End: 7/22/2026
 - Allocations as follows:
 - Add FY 2025 Hampton Roads Transportation Accountability Commission (HRTAC) allocation of \$1,208,574
 - Add FY 2026 HRTAC allocation of \$63,926,489
 - Add FY 2027 HRTAC allocation of \$114,656,358
 - Obligations as follows:
 - Add FY 2025 PE Phase Other obligation of \$1,880,000

UPC 125602 is a non-exempt, regionally significant project that is being added to the Hampton Roads FY 2024-2027 TIP. It is included in the HRTPO 2045 Long-Range Transportation Plan (LRTP) and is fiscally constrained as required by Federal Code 40 CFR 93.108. As a regionally significant project, this TIP Amendment is subject to conformity per the [Procedures for Inter-Agency Consultation for Conformity \(IACC\) for Hampton Roads](#). After HRTPO Board approval, HRTPO staff will submit the streamlined conformity documentation to FHWA/FTA to initiate the federal review process.

This request is being made available for public review and comment from November 6, 2024 through November 20, 2024. This agenda note serves as the IACC with any comments submitted to John Mihaly (jmihaly@hrtpo.org) before COB November 20, 2024.

Dear Mr. Crum,

The Virginia Department of Transportation (VDOT) requests a TIP Amendment from the Hampton Roads Transportation Planning Organization (HRTPO) to add UPC 125602, I-64/I-264 Interchange Phase IIIA, to the FY 2024-27 TIP. This project will widen I-64 Eastbound from four to five lanes, including the reconstruction off the interchange flyover ramp from I-64 Eastbound to I-264 Eastbound, and widening of three existing bridges. Managed lane infrastructure will be installed in the eastbound median. The allocations within the TIP years currently reflect a \$337,224,579 deficit. The out-year allocation funds will be provided by HRTAC. Fiscal constraint of the subject project has been demonstrated and all funding has been identified. To that end, we request UPC 125602 be added in the FY 2024-27 TIP including the following information:

- UPC 125602 – I-64/I-264 Interchange Phase IIIA
 - Non-Federal Oversight
 - Add FY Previous Obligations
 - No Previous Obligations
 - FY 24 - 27 Obligations with the following:
 - PE (FY25) Federal- Other \$1,880,000
 - Add Estimate \$517,016,000
