The Virginia Department of Transportation (VDOT) requests a TIP Amendment from the Hampton Roads Transportation Planning Organization (HRTPO) revise the schedule, cost estimate, allocations, and obligations for UPC 113468, Parliament Drive Sidewalk Phase II. This project will provide a five-foot sidewalk along the southern side of Parliament Drive from Green Kemp Road to the Arrowhead Plaza Shopping Center. Fiscal constraint of the subject project is demonstrated. To that end, we request UPC 113468 be revised in the FY 2024-27 TIP including the following information:
