The summary of the December 8 meeting is attached for review and approval. Summary highlights include:

- GAC 2021 The Committee is still working towards planning small socially distant, local events (mostly individually-led) to be held March 26-27, 2021. KVB doing their Shiver in VA month-long challenge in March, could co-promote to GAC volunteers. Localities are beginning to plan events and should report plans to HRPDC staff for tracking.
- Recycling Outreach The Committee discussed updated materials for the Start Smart, Recycle Right outreach campaign: rack card & videos. HRPDC staff will convey feedback to Red Chalk to finalize materials as well as the quiz and webpage content. Launch of the campaign is pushed to January 2021 for the start of the new year.
- Cigarette litter outreach Committee members continued discussing plans for the #NoButtsAboutIt campaign. HRPDC staff provided signage options for feedback. Committee members should continue planning locations and arrange to pick up butts for photos to be taken. HRPDC staff will send revised signage via email. The Committee also discussed launching a cigarette waste receptacle grant program – a shared initiative with the Stormwater Education Committee. HRPDC staff will provide information and pricing at the January meeting.
- Grants The DEQ Review Board is supposed to be meeting in January to discuss applications. HRPDC staff will provide an update once one is available.
