7. Regional Connectors Study - presented by Lorna Parkins, Michael Baker International Office Executive

The HRTPO has been conducting the Regional Connectors Study with HRTAC funding via a consultant contract with Michael Baker International. The purpose of the study is to establish a long-term vision that investigates transportation options that connect the Peninsula and the Southside while improving economic vitality, resiliency, accessibility, and quality of life in the region. The study will evaluate the feasibility, permitability, and transportation benefits of the segments presented in the Hampton Roads Crossing Study (HRCS) Supplemental Environmental Impact Statement (SEIS) that were not included in the Preferred Alternative approved by the HRTPO and the Commonwealth Transportation Board. The SEIS preferred alternative was to widen I-64 to a consistent six-lane facility between I-664 in Hampton and I-564 in Norfolk, including the expansion of the existing Hampton Roads Bridge Tunnel. Once complete, the RCS will provide recommendations for segment tiering and will document study findings for use in future project evaluations.

The Regional Connectors Study was previously presented to the CAC on October 19, 2022. This presentation will highlight project updates and community input received during the February public meetings.
