#### 4. Printing & Promotional Materials

## 6. FOG Regional Website & Training Updates

The Committee finalized the FOG training documents and tests.

- Amanda observed a HGI self-cleaning and it took many trash bags/liners to empty the device.
- Added slide to demonstrate issue with concrete and epoxy-coated GCDs.
- Resources including the yellow grease rack card will be translated into Chinese and Spanish once finalized.

The Committee reviewed the new HGI Cleaning Guide rack card.

- Address changes to trash can/trash liners to be consistent with training.
- Change sizing to state “25 gpm and under”
- Other feedback was submitted sent via email.

CDM Smith continues to work on the enhancements list for HRFOG.com. HRPDC staff is in the process of procuring security certificates which will make HRFOG.com a secure website.

**Action:** HRFOG training documents and tests were finalized. HRPDC staff will continue to work with CDM Smith on HRFOG.com enhancements.

## 7. Roundtable & Public Comment

- HRSD -
  - Arizona FOG program does not allow dumpster disposal of self-cleaning contents. Instead, they require a brown grease container which must be pumped out like yellow grease.
  - Wastewater Treatment Plant updates
    - BEAST/CAMBI system at Atlantic Plant uses thermal hydrolysis to separate FOG and inject it back into the system at different points for beneficial use.
    - Chesapeake Elizabeth plant closing October 2021
    - Nansemond plant has Greasezilla for FOG receiving station.
    - Boat Harbor - full load FOG receiving station.

- Williamsburg - dedicated FOG receiving station; closing for 10-week cleaning/maintenance which may impact haulers.
- Western States Alliance FOG Forum free trainings available
- Virginia Beach - Schier has new owner's manual with updated performance data: <https://schierproducts.com/literature/>; recommends Schier reps to attend upcoming meeting to discuss models with no flow control device; March 1<sup>st</sup> the plumbing Code changes were published: <https://www.iccsafe.org/about/news-and-events/2021-cah/>; Brent Werlein will attend hearing set for April to defend proposed plumbing code changes
- Chesapeake - need photographic support to use in educating City Council about FOG problems and why a FOG program is needed.
- Norfolk - working with Stormwater Department to identify and respond to oil/grease spills

- *Budget* - The Committee reviewed the FY21 budget. Reserve funding used to purchase three-inch no grease sign stickers. About \$9,000 in reserves anticipated for FY21.
