IV. Discussion of HRPDC/HRTPO Regional Legislative Agenda

For the past six years, the HRPDC and HRTPO have adopted a regional legislative agenda to convey to the General Assembly and Federal Delegation issues of regional significance that should be addressed on behalf of Hampton Roads. This regional legislative agenda is typically approved by the Commission and HRTPO Board at their October/November meetings to allow these regional legislative priorities to be shared with Hampton Roads Caucus members before the start of the General Assembly session in January.

Last year, a Joint HRPDC and HRTPO Regional Legislative Committee was formed to develop a recommendation for a regional legislative agenda to be considered by the Commission and HRTPO Board. The current membership of this Hampton Roads Regional Legislative Committee is as follows:

A potential schedule for developing and finalizing the regional legislative agenda is as follows:

August 29: Regional Legislative Committee receives and discusses recommended draft agenda for discussion and consideration.

September 7: Chief Administrative Officer (CAO) Committee discusses proposed regional legislative priorities and input received by Regional Legislative Committee

Mid to Late September: Schedule the second meeting of Regional Legislative Committee

October 20: HRPDC and HRTPO consider approval of Regional Legislative Agenda. If needed, approval could occur at November 17 meetings.

Mr. Robert Crum, HRPDC/HRTPO Executive Director, will brief the Committee on last year's regional legislative agenda, related actions by the Virginia General Assembly, and request input from Regional Legislative Committee members on potential topics that could be regional legislative priorities to be considered by the HRPDC and HRTPO.
